**Instructions for Permit Applications:** (All information must be printed legibly)

1. Owner name, address & phone number
2. Location & address of work site
3. Complete description of work to be done
4. Number of fixtures, appliances & equipment to be installed
5. Plans must be submitted on all new buildings & major renovations

It is the responsibility of all contractors, electricians and plumbers to obtain the necessary permits from the Building Department before ANY work has begun. Work must begin with six months of the issuance of any permit.

Electricians must have a valid license from the State of New Hampshire to obtain a permit. Permits are not transferable.

It is the responsibility of the contractor to obtain all inspections required. A rough-in inspection is required before any work is covered, and a final inspection is required when all work is complete. A twenty-four hour notice is required for any inspection. This signed application constitutes consent on the applicant's part to allow for all inspections at the property location listed.

Permits will not be issued until all of the required information has been furnished and all conditions mentioned above have been met.

It is the responsibility of the property owner and/or the contractor to contact Eversource after Town approval to schedule for connection.

**INSPECTIONS REQUIRED:** (24 HOUR NOTICE REQUIRED)

1. Underground conduit installations
2. When service is installed and a work order number has been obtained from Eversource
3. When rough-in is complete and visible (Rough)
4. When job is complete.

Building Inspector approval certifies that the applicant can proceed with installing Electrical fixtures in accordance with the specifications submitted. Any deviation from the specifications submitted will require an amendment to this permit or additional permits.

**STATEMENT OF COMPLIANCE:**
