**OUTDOOR FACILITY USE AGREEMENT**  
**AND**  
**RELEASE/INDEMNIFICATION**

- A. In consideration for being permitted to use the facilities of the Town of Loudon, \_\_\_\_\_ (hereinafter "Applicant") agrees (insert name of person/entity seeking permission to use facilities) to indemnify and hold harmless, the Town of Loudon, its officers, employees, insurers, and New Hampshire Local Government Center Insurance Programs, from and against all liability, claims, and demands, which are incurred, made, or brought by any person or entity, on account of damage, loss, or injury, including without limitation claims arising from property loss or damage, bodily injury, personal injury, sickness, disease, death, or any other loss of any kind whatsoever, which arise out of or are in any manner connected with the use of the facilities, whether any such liability, claims, and demands result from the act, omission, negligence, or other fault on the part of the Town of Loudon, its officers, or its employees, or from any other cause whatsoever.
- B. By signing below, Applicant agrees that, in the event of any damage, loss, or injury to the facilities or to any property or equipment therein, the Town of Loudon may require the full amount of such damage, loss, or injury. Applicant will within thirty (30) days of billing reimburse the Town of Loudon for all costs associated therewith upon billing by the Town of Loudon.
- C. In addition, in consideration for being permitted to use the facilities, Applicant, on behalf of itself, and its officers, employees, members, and invitees, hereby expressly exempts and releases the Town of Loudon, its officers, employees, insurers, and self-insurance pool, from and against all liability, claims, and demands, on account of injury, loss, or damage, including without limitation claims arising from property loss or damage, bodily injury, personal injury, sickness, disease, or death, that Applicant may incur as a result of such use, whether any such liability, claims, and demands result from the act, omission, negligence, or

other fault on the part of the Town of Loudon, its officers, or its employees, or from any other cause whatsoever.

- D. Applicant is advised that **No Alcohol** is allowed on Town of Loudon Property and it shall be the responsibility of the Applicant to take the necessary actions to ensure that all attendees and persons associated with the activity to which this usage pertains are aware of and comply with these requirements.
  
- E. Applicant agrees with the condition that all trash is to be cleaned up from the area of permitted use and deposited in the appropriate containers. If no containers are available, Applicant will remove trash by his/her own means.
